AMENDMENT TO TRUST DEED

This amendment to Deed of Trust executed on this 19th day of January 2018 by:-

Ka. Nedunchezhian, Son of Mr. S. Kaliyamoorthy, aged about 42 years residing at No.5, Appukutty Street, Kumbakonam – 612 001 being the **AUTHOR OF THE TRUST.**

WHEREAS THE Trust deed was originally executed on 24th day of October 2016, registered vide **Document No. 126 of 2016** under

the name and style of "THE GROW RICH FOUNDATION" and has been carrying on its activities since then.

WHEREAS the Trust has applied for granting an approval U/s. 12AA of the Income Tax Act and it is deemed necessary to amend certain provisions to bring clarity and include certain clauses of the said deed to have the benefits of Registration u/s. 12 AA & 80G of the Income Tax Act, 1961. This supplementary Deed of Trust is Witnesses as under.

Original Trust deed Page No.7 primary objects clauses 1.1 to 1.32 shall stand deleted and replaced with the following clauses:

- 1.1 To educate people, to work and support for the advancement of education, to provide financial assistance to education, to help poor and needy persons for continuing their education, to support educational centers / institutions.
- 1.2 To provide relief for the poor by assisting them for their basic requirements, to enhance the skills of poor especially in villages, to assist agriculturists in farming, fishing and allied sectors to improve their skills and support them free of cost.
- 1.3 To create economic awareness among illiterate, to provide financial assistance to poor and needy people, to provide support to poor, destitute, transgender, advancement of health, saving of lives, advancement of citizenship, advancement of arts, culture, heritage and or science, advancement of amateur sport, advancement of environmental protection or improvement free of cost.
- 1.4 To assist self help groups, disabled, to conduct training program free of cost, to provide various types of skill training free of cost, to provide medical aid, to educate them in health consciousness, to provide medical relief to poor, to conduct health camps, providing medicines etc.., free of cost.

To assist in the advancement of animal welfare, to provide ambulance services free of cost, to engage in the charitable activities as mentioned above and other activities which are charitable in nature.

Original Trust deed Page No.15 clause 6.8 Para 1 shall be amended as follows:

The trustees are not entitled to any remuneration / salary for the services rendered by them.

Original Trust deed Page No.20 the following to be included as Clause no.9:

- 9.1 The Trust created shall be **IRREVOCABLE** and the same is hereby declared as irrevocable under any circumstances. In the event of dissolution of the Trust the properties and funds remaining shall be transferred or paid to some other Trust or Institution having similar objects or any other registered Society or Company with similar objects registered under section 12A of the Income Tax Act, 1961. Any change / amendment in trust deed shall be made only with prior approval from The Commissioner of Income Tax (Exemptions). Similarly any transfer of immovable property held by the trust shall be made only with prior approval from The Commissioner of Income Tax (Exemptions).
- 9.2 The Trust funds shall be invested from time to time, in accordance with the provisions of Section 13(1)(d) read with Section
- 11(5) of the Income Tax Act, 1961. The Trust funds will be utilized only for carrying out the objects for which the Trust is established.
- 9.3 The Income of the trust shall be solely utilized towards the object and that the funds or assets will not be utilized for the payment to the author / trustees of the trust by way of share in profit / dividend etc...
- 9.4 The Trust shall not carry on any activity with the intention of earning profit. Activities of the Trust would be confined to the territory of India.
- 9.5 The benefits of the Trust would be available to the general public irrespective of caste, creed, religion, sex etc.
- 9.6 The Trust shall not spend more than 5% of its income towards religious activities.
- 9.7 The activities of the Trust would be purely charitable in nature and not motivated for profit.

The above clauses in the original Trust deed hereby amended / included by the Founder of the Trust.

All other terms and conditions as per the original deed of trust shall remain the same.

1. Notes on Activities:

- Irrevocable clause: The trust formed is irrevocable. Please see clause 9.1 of the Trust deed / amended deed.
- Investment clause: Please refer clause 6.23 and 9.2 of the trust deed / amended deed.
- 8. Accounts clause: Please see clause 6.16 of the trust deed regarding maintenance of accounts and audit by a Chartered Accountant.
- 9. Utilization clause: Please refer clause 9.3 of the trust deed / amended deed regarding application of funds of the trust.
- 10. Dissolution clause: Clause 6.24 of the trust deed explains regarding dissolution of the trust, which states that in the event of dissolution of the Trust, the net assets of the Trust shall be transferred to trust having similar objects of this Trust.
- 11. Amendment Clause: Refer clause 9.1 of the Trust deed / amended deed.
- 12. Beneficiary clause: Refer clause 9.5 of the Trust deed / amended deed which states that the benefits of the Trust are open to all persons irrespective of caste, religion, race, sex etc... The trust deed does not state that the benefit of the trust for any particular religious community or caste.
- Clause 9.4 of the Trust deed specifically provides that the activities of the Trust shall be carried out only in India.
- 14. Income tax return: The trust was formed on 24.10.2016. Income tax return for the F.Y. 2016-17 will be filed.
- The Trust is not carrying on any business.

- 16. The Trust deed does not mention anything about receipt of foreign contribution.
- 17. Yes. The Trust has utilized 85% of its income as required u/s.11 of Income tax Act.
- 18. We have not made any application in Form 10A or Form 10G earlier.
- 19. Amendment to Trust deed is enclosed herewith.
- Yes. Amendment to Trust deed executed by the Author of the Trust. The author is continuing in the Trust.
- Copy of Bank statement from the date of constitution to till date is enclosed herewith.
