


- 1.16 To develop and mobilize community and Natural resources to give the right direction to people of the marginalized and economically weaker section of the trust for their sustainable overall development.





The number of Trustees including the Managing Trustee shall not exceed 07 at any time. The term of office of the Permanent Trustees shall be for life. The term of office in case of nominated or co—opted trustees shall be for 5 years. There after they will be eligible for reappointment. Any Trustee in case of nomination or co-option may retire on giving one month notice in writing thereof to the other.

A Trustee shall automatically cease to be and shall vacate the office of the Trustee on the happening of any of the following:-


- (i) By death, resignation or retirement;
- (ii) If he is adjudged insolvent or if he applied to be so adjudged;
- If he is convicted of any offence (other than an offence not involving moral turpitude) and is sentenced in respect thereof to imprisonment;
- (iv) If in the opinion of the Managing Trustee and majority of other Trustees, the continuation of any trustee in the board is detrimental to the interest of the Trust;

Vacancies occurring in the office of the Trustees whether such vacancies are caused by death, resignation, retirement or for any other cause shall be filled by the Chairman / President of the Managing Trustee.

03. THE BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:

- 6.1 To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 6.2 To accept donations, contributions, grants, subscriptions in cash or in kind from any person, company, firm, associations, organizations, state and central government, non-government or semi-government agencies, national or foreign funding agencies, Foreign Government, Foreign donors, Foreign Institutional donors, family trust, or corporate bodies for furtherance and achievement of the primary and secondary objectives of the Trust.
- 6.3 To appoint a Managing Trustee, when necessary.
- 6.4 To review the affairs of the Trust and a necessary.




- 6.5 To appoint officers and members of staff for the Trust and to prescribe their condition of service.
- 6.6 To open and to provide for operating banking accounts
- 6.7 To rise loans with or without security or to invite donation and financial help.
- 6.8 To receive the honorarium or salary against his/her services or involvement in any of the project or programme run by the Trust, which must be decided by the Board of Trustees and approved by the Chairman/Chairperson.

The Trustee for the time being may reimburse themselves or himself on pay and discharge out of the Trust Fund all expenses properly incurred in or about the execution of the Trust on powers under these presents

- 6.9 To authorize person (s) to sign or execute documents on behalf of the Trust.
- 6.10 To grant receipts for aid or donation received.
- 6.11 To grant Special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
- 6.12 To acquire land or building on the lease or way of purchase at future.
- 6.13 To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust Property or Properties.
- 6.14 To sell or give on rent/lease or on hire any movable or immovable properties which may be acquired in future of the Trust for some certain period (s) on such terms and conditions as the Trustees may think fit and proper from time to time.



6.16 The financial year for the Trust shall be from 1st April to 31st March and the accounts of Trust or Institution (s) or Programme (s) run b y the Trust shall be audited yearly by the auditors (s) or chartered accountant or a firm of chartered accountants to be appointed by the Board of Trustees and the fee for auditor (s), if paid, shall be a part of outgoing amounts from the Trust Funds.

6.17 To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, persons, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.

6.18 To gift, lease, and transfer the movable and immovable properties in future of the Trust.

6.19 To appoint Legal Consultants, Advisory Members 1997.

Pleaders, Advocates, to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officer (s), employee (s), staff (s), and Trustee (s) for such proceeding (s) as required from time to time.


6.20 To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.

6.21 To appoint from time to time on such terms and conditions as they may determine a Secretary, Manager, Executive Director, Director (s) and other Officer (s) or member (s) or staff (s) for carrying out the activities of the Trust and to remove at any time any such Secretary (s), Manager (s) Executive Director, Director (s) and other officer (s) member (s) or Staff (s).

6.22 After defraying all necessary expenses incurred in the collection or realization of the income from the Trust ten percent (10%) of the balance of the income shall be kept in a reserve fund to be utilized when, in the opinion of the Board of Trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust.

6.23 The Trustees shall invest the Trust fund in Government Securities, Savings Certificates, Government Bonds, and Fixed Deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME ACT, 1961, as they shall deem expedient.

6.24 It has further been decided that as and when its enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.

6.25 All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting or Board of Trustees or by the circulation, as the case may be and any action or decision of such majority shall be valid as if it was done or made by the all Trustees. The Chairman/Chairperson shall have a casting vote.


6.26 In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy.

7. MEETING OF TRUSTEES:-

7.1 The Trustees shall hold meeting at such intervals as they may decide. However, at least once in every three monthly meeting being known as "Quarterly General Meeting" shall be held. At every Quarterly General Meeting of the Trust, the Secretary shall read before the meeting a report of the activities since the previous Quarterly General Meeting and lay before the Board of Trustees, the Income and Expenditure Account and Balance Sheet of the Trust for the previous Quarter.

7.2 The trustees shall hold meeting at such intervals as they may decide. Apart from the Quarterly General Meeting, in every year an Annual General Meeting shall be held. At every Annual General Meeting of the Trust, the Secretary shall read before the meeting a report of the activities since the previous Annual General Meeting and lay before the Board of Trustees, the audited Income and Expenditure Account and Balance Sheet of the Trust for the previous year.

7.3 The number of trustees of the Board shall not be less than 3 and more than 7, each of whom shall have an equal vote. If the numbers of trustees fall below 3, the remaining trustees shall not act on behalf of the Foundation, except for the purpose of a fulfilling a vacancy, as long as the number of trustees is below the minimum.

7.4 The Board of Trustees shall transact any business that may be specified in the agenda or otherwise agreed by the Board members present. Presence of 2 members at a meeting shall form Quorum for any meeting of the Trustees.

7.5 The vote of the majority present and voting at the meeting shall prevail and in case of equality of votes the Chairman shall have a casting vote.

7.6. No act or resolution of the Board of Trustee shall be invalid merely by reason of the existence of one or more vacancies in the Board of Trustees.

7.7 For every meeting, a notice of at least seven days must be given. The notice may be given by post or by hand delivery addressed to the respective addresses of the Trustees registered with the Trust, but the accidental omission to give such notice or non-receipt thereof by any Trustee shall not invalidate the proceedings at any meeting of the Board of Trustees.

7.8 All the meetings of the Board of Trustees shall be presided over by the chairman of the Trust, and in his absence any one of the Trustees may be requested by the Board of Trustees to be the chair man of the said meeting.

8. All matters not provided for in this Trust deed but necessary for the administration of the Trust of for giving effect to the objectives of the Trust may be resolution (s) made by the Board of Trustees carried by a special majority of two third of total number of the Trustees.




